Panel discussion on Future of Cadastres

GIM International and FIG Commission 7 collaborated on organising a special session on the future of cadastres, in follow-up to a previous special session on this topic held at the 2011 Working Week in Marrakech. The following themes were discussed: the evolving role of land professionals, AAA vs Open / Crowdsourced Cadastre, informal rights and overlapping claims to be included in land administration, 3D and 4D in land administration. There was general agreement on the need for transparency, and that approaches in land administration must involve citizens. The importance of new technologies, alternatives for data acquisition and the quality challenges were also examined.



World Bank Conference Land and Poverty

Spatial Enabling Governments and Societies was also the topic of a joint workshop during the 2012 Annual World Bank Conference on Land and Poverty (www.landandpoverty.com) in which FIG Commission 7 played a very active role. A one-day workshop on 'Spatially Enabled Government and Society' was held at the World Bank Headquarter on 24 April 2012. This joint FIG and Worldbank workshop addressed various and related issues:

- Triple A land administration: from concept to implementation
- Approaches to lower-cost land administration through spatial enablement;
- Potential and challenges of spatial enablement of land administration;
- Spatial enablement to sustainably support the continuum of land rights.

Spatially enabling Governments and Societies (SEGS) will require structural changes in the institutional, legislative and professional domains. In this regard, the role of the land surveyors will have to evolve to better respond to the need of the society and propose better fit-for purpose approaches.

The chair of the Working Group 7.1 Pro Poor Land Tools, Christiaan Lemmen, gave a presentation about “Land Administration and the Evolving Role of the Surveyor”¹. The paper highlights that there is no doubt that surveyors are critical to the future society of both developed and developing world.

The adoption of the continuum of land rights was also one of the main highlights of the Annual World Bank Land Conference.

News from the Working Groups

Working Group 7.1 Pro-Poor Land Tools

WORKSHOP: LADM from Research to Implementation – Land Administration Domain Modeling at a threshold

The international workshop LADM from Research to Implementation – Land Administration Domain Modelling at a Threshold was held on 6 July 2012 at the Rotterdam offices of Netherlands Kadaster. The event was co-organized by Faculty ITC of the University of Twente,

the UNU School for Land Administration Studies, Netherlands Kadaster, Delft University of Technology and the International Federation of Surveyors (FIG).

Together with developments in 3D cadastres and the acceptance of the continuum of land recording, the LADM represents perhaps the most significant technical development in land administration over the past decade. While the model in itself provides a much sought-after design standard, even more impressive has been its capacity to inspire collaboration, dialogue, shared understandings, and general awareness among land administrators globally. The challenge now is to convince those outside the development process of the importance and utility of LADM in a practical setting.

The International Standard is expected by the end of 2012.

Working Group 7.2 Climate Change and Disaster Management

Under the joint project with UN-FAO to develop online training materials on land administration and disaster management Working Group 2 there were several activities during the last period:

- As mentioned earlier Working Group 2 organised a joint Special Training Session with UN FAO during the Rome Working Week on Disaster management at the FAO Headquarters (see more details below).
- During July, David Mitchell ran face-to-face training at the University of the South Pacific and these proceedings were video-recorded.
- Agreement was reached with UN-FAO to develop further training materials suitable for online format:
 - FAO is organizing face-t-face training in the Carribean in the second half of 2012 and Jaap Zevenbergen will attend.
 - Background reports on Spatial Information Management, Land use planning, and property valuation and DRM are being prepared by Jaap Zevenbergen, Francis Roy and David Mitchell in cooperation with FAO.

As previously mentioned, the Working Group 7.2, co-organized a Training Session with FAO on Tuesday 8 May at the FAO Headquarter. The Session was made up of two blocks, one with mainly FAO speakers, and one with FIG speakers, after a joined welcome by Paul Munro-Faure, Principal Officer, Land Tenure Group FAO, and Daniel Roberge, Chair Commission 7 FIG. For FAO spoke on behalf of the Emergency Operations Group, Sylvie Wabbes Candotti and from the Land Tenure Group Paul Munro-Faure. After that a panel co-chaired by Stephan Baas and Adriana Herrera with regional examples from the West-Indies (Charisse Griffith-Charles) and Philippines (Arnulfo M. Mascariñas) were presented.

In the FIG block Daniel Roberge gave an overview of FIG and especially Commission 7. The working group co-chairs, David Mitchell and Jaap Zevenbergen, spoke respectively on Integrating land issues and land administration into Disaster Risk Management (DRM) and on Effective Spatial Information Management for DRM. Francis Roy spoke on Land management and land use planning to support DRM. A real example from New Zealand was presented by Nic Donnelly.

After some discussion, we all agreed that land issues are important for DRM, and that the current knowledge and experiences need to be shared more in both the DRM and land communities. This session was a first step to make that happen.

This session is part of a broader co-operation between FAO and FIG working group 7.2, that was detailed during a joint meeting in Rome on 20-21 October 2011, and will lead to extension of the FAO Land Tenure Manual 3 'Assessing and Responding to Land Tenure Issues in Disaster Risk Management' and the development of some e-learning materials, as envisaged in the commission 7 work plan.

Working Group 7.3 Cadastral Perspectives

Based on the results of the two major events of the WG in 2011 - the joint Seminar on 3D Cadastre, co-organized with FIG Commission 3 in Delft/NL and the International Symposium "Cadastre 2.0" organized by WP 7.3 in Innsbruck/AT, delegates of Commission 7 have been active in further developing visions and strategies for the future of cadastre.

Some of the first results have been presented in several Technical Sessions during the WW 2012 in Rome. Well attended sessions reflect the high interest among the FIG family into the topics which are on the schedule for the next two years, such as:

- involvement of social media into cadastral procedures
- influence of IT on cadastre in general
- data capture besides existing models
- voluntary participation in e-government procedures
- multifunctional cadastre as a successor of multipurpose cadaster
- multidimensional cadastre, as a topic of joint interest with FIG Commission 3
- quality level, social media and web 2.0 applications
- technical framework to guarantee flexibility for future development

The contributions to the Proceedings of the Symposium "Cadastre 2.0" cover a wide range of topics and supported to raise awareness among stakeholders and interest groups. Distribution on demand is still going on.

Working Group 7.4 Land administration

The working group 7.4 organized an international seminar on 20-21 September 2012 in Budapest, Hungary. This seminar examined the management of state and public sector lands in transitional countries. The seminar was organized in collaboration with the FAO Regional Office for Europe and Central Asia in Budapest

The main themes of the seminar included how the FAO Voluntary Guidelines on Responsible Tenure affect the management of state and public sector land, how the management of state and public sector land has changed in transitional countries during the last two decades, the management of state agricultural land, land consolidation, managing the sale of state land, developing management systems for state land, and cadastres and the management of state land.
